chlorination and dichlorination in October. We will submit our updated compliance plan to IDEM next week.

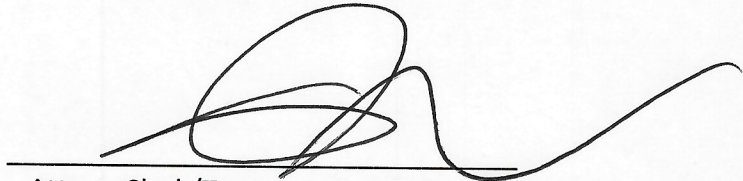

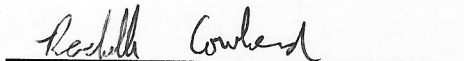
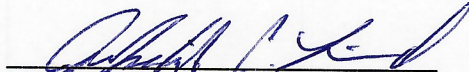
